This rate is equal to an 18% annual percentage rate. 3. Any discrepancies, shortages, claims or incorrect shipments shall be reported by telephone, and followed by fax, to the company immediately upon receipt, and in no event, later than 10 calendar days after said receipt. 4. The company shall be responsible for curing said discrepancies only if notified by the said 10 calendar day period. 5. Any discount allowed by the company shall apply to merchandise only: Sales tax and Freight shall not be discounted. 6. If any legal action is required to enforce any provision of this agreement, the prevailing party shall be entitled to recover attorney's fees, costs and reasonable expenses incurred in such action. 7. California law shall govern the agreement between the parties. 8. The person signing this agreement for the customer represents and warrants that he or she is authorized and empowered to execute this agreement on behalf, or as the agent, of the customer.
